- 5. Flat Tires. Renter acknowledges that they could run over something sharp and get a flat tire. Before leaving the store, Renter can borrow a free flat tire repair kit. If Renter declines a flat tire repair kit and gets a flat they should call Downtown so we can figure out how best to resolve the problem.
- 6. Snapped Chains. Pedaling uphill in a high (wrong) gear puts stress on a chain. If Renter needs a quick lesson on shifting, Downtown can explain. Downtown can also provide a chain breaker and a master link in case Renter stresses and snaps their chain.
- 7. Un-fixable Mechanical Breakdown: Call Downtown.
- 8. Free Lock, Helmet, and Map.
- 9. Operator Damage to Bike. Renter agrees to return rental bike in the same condition as it was rented. Renter agrees to pay for repair of bike (especially the wheels) caused by a crash or any kind of impact.
- 10. Theft of Bike. If the rental bike gets stolen, Renter authorizes Downtown to charge Renter's credit card for the retail price of replacing it.
- 11. Indemnification. If Renter is injured on their bike ride and Renter's insurance company pays their hospital/medical/rescue expenses, Renter will stand between and defend against a claim made by their insurer against Downtown. In legal terms this means Renter will indemnify Downtown. More specifically, no agreement between Renter and their insurance company permitting the latter to recover paid medical expenses (subrogation) will trump this agreement between Renter and Downtown. Likewise, if Renter has no medical insurance, Renter will stand between and indemnify Renter from any claim made by a hospital, doctor, or medical professional against Downtown.
- 12. Alaska Law: This Agreement is controlled by Alaska law. A person or entity attempting to enforce or invalidate any portion of this Agreement, must litigate under Alaska law in Anchorage, Alaska.
- 13. Attorneys Fees: If Renter fails to honor any one or more of the clauses or provisions of this Agreement, or if Renter tries to circumvent this Agreement and brings legal action against Downtown, Downtown's attorney fees for successfully defending this Agreement will be paid by Renter.
- 14. No Verbal Terms: The terms and conditions in this Agreement cannot be verbally waived or changed. Only written changes specifically agreed to by both parties can be changed, waived, or amended
